#### 2. NOTICE TO TERMINATE A FIXED TERM TENANCY

#### 3. SHOWING THE UNIT

A KPM Representative may enter the rental unit without written notice to show the unit to prospective residents between the hours of 9:00 AM and 8:00 PM.

#### 4. KEYS

All keys must be returned at the time of vacating the premises. Failure to do so will result in locksmith charges.

#### 5. CLEANING
